BE IT FURTHER RESOLVED, a portion of the Banked Cap Tax Levy Adjustment in the amount of \$225,749 is included in the 2016-2017 preliminary budget permitting the tax levy to increase above 2% which is to be utilized for the purpose of replacing windows at County Road School. The windows in County Road School are original to the building, not energy efficient and in need of replacement. This project needs to be completed in entirety and should not extend over a period of time since the small size of the school does not warrant completing the project over an extended period of time.
