RESOLUTION OF THE BOARD OF EDUCATION OF THE BOROUGH OF DEMAREST IN THE COUNTY OF BERGEN, NEW JERSEY, AUTHORIZING A PUBLIC HEARING AND THE PUBLICATION OF THE NOTICE THEREOF IN CONNECTION WITH A LEASE PURCHASE TRANSACTION

January 19, 2021

WHEREAS, The Board of Education of the Borough of Demarest in the County of Bergen, New Jersey (the "Board" when referring to the governing body and the "School District" when referring to the territorial boundaries governed by the Board) has determined to undertake a capital project consisting of the construction and equipping of an addition at the County Road School (the "Project") for an estimated cost of \$4,110,000; and

WHEREAS, the Board desires to finance the Project pursuant to a lease purchase agreement as permitted by N.J.S.A. 18A:20-4.2(f) (the "Lease Purchase") in an amount not to exceed \$4.110,000; and

WHEREAS, pursuant to N.J.A.C. 6A:26-10.3, the Board is required to conduct a public hearing on the Project and the proposed Lease Purchase; and

WHEREAS, in addition, the Board may seek to refinance the balance of the outstanding lease purchase dated August 15, 2018 issued in the original amount of \$1,030,000 in order to produce interest savings in light of reduced tax-exempt interest rates (the "Refinancing"); and WHEREAS, the Board seeks to further consider an additional lease purchase in the approximate amount of \$450,000 to accomplish the Refinancing; and

WHEREAS, the Board desires to include the potential Refinancing as part of the public hearing; and

WHEREAS, the Board seeks to set a date for such public hearing and to authorize notice of such public hearing to be advertised in <u>The Record</u>.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BOROUGH OF DEMAREST IN THE COUNTY OF BERGEN, NEW JERSEY as follows:

Section 1. The Board hereby authorizes a public hearing on the Project, the Refinancing and the Lease Purchase to be held on February 9, 2021 at 7:00 p.m. at the Luther Lee Emerson Elementary School.

Section 2. Wilentz, Goldman & Spitzer, P.A., Bond Counsel is hereby authorized to advertise the notice of such public hearing in
The Record.

Section 3. This resolution shall take effect immediately.
