DEMAREST BOARD OF EDUCATION

MINUTES - REGULAR MEETING

January 28, 2014

I. <u>OPENING</u>

- A. The meeting was called to order at 7:00 p.m.
- B. Board President's Announcement:

The New Jersey Open Public Meetings Law was enacted to insure the right of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interests is discussed or acted upon.

In accordance with the provisions of this Act, the Demarest Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted at the Borough Hall and at the Middle School and by notifying in writing two newspapers: The Record and The Suburbanite.

- C. President Holzberg led the flag salute.
- D. Roll Call: Geisenheimer, Kirtane, Molina, Verna, Woods and Holzberg were present. Geller was absent.
- E. It was moved by Geisenheimer, seconded by Woods and approved by unanimous voice vote to accept the minutes of the COW/Regular Meeting from December 17, 2013.
- F. There was a review of correspondence.

II. BOARD PRESIDENT'S REPORT

President Holzberg welcomed everyone to the meeting. She recognized the board for their service and stated that January is School Board Recognition Month. She expressed she was pleased to have students here this evening to present.

III. SUPERINTENDENT'S REPORT

Mr. Fox commented that he is proud of the district's board members. He noted that the administration has been busy observing teachers and the students have been practicing online test taking in preparation of the state tests. The sixth grade has been chosen to take the test.

Mr. Kirkby introduced Mr. Nerkizian and Ms. Straub, teachers from Luther Lee Emerson School, who presented with students. Mr. Nerkizian shared programs on the iPad with participation of the board members. Ms. Straub explained how students are learning to use QR codes.

Mr. Kirkby reported on the elementary school activities including Fire Safety, SuperKid and Kindergarten Roundup. He explained the schools are preparing for Lunar New Year celebrations and Jump Rope for Heart.

Dr. Codey spoke about the middle school's activities including Peer Leaders, NASA Scientific, the Bake Sale for Philippines, the collection of 2200 food items for SuperBowl project and the PTO's sponsorship of Sportsology. She commented on the great success of the 5th and 6th grade dance. She explained that the students are preparing for the Geography Bee. She exclaimed that the winter concerts were special and the choir has doubled in participation. She also noted that the Multiple Intelligences students participated in World Games at Dwight Englewood.

Mr. Fox commended Dr. Codey and Mr. Kirkby on the teacher evaluations they completed. He explained that the district just received its Performance Report which showed good student growth. He said the administration is focusing on attendance and algebra. He noted that the following committee meetings need to be scheduled: Building & Grounds, Policy and Finance.
